Estanques temporales mediterráneos con comunidades semiacuáticas de *Eleocharis multicaulis* y comunidades herbáceas sobre suelos encharcados temporalmente (*Junco-Isoetetum velatae* y *Sisymbrello-Preslietum cervinae*) con *Marsilea strigosa*. Constituyen hábitats únicos en la Comunitat Valenciana, a la vez que son refugio de especies de plantas muy raras incluidas en el Anexo II de la Directiva.
