Other Site Characteristics

El archipiélago está constituido por cuatro pequeños conjuntos de islas e islotes; el de la Columbreta "Gran", en la que puede reconocerse el antiguo cráter volcánico, el de "Ferrera", "Foradá" y el del "Bergantín". Hace años fueron objetivo de pruebas militares.

4.2 Quality and importance

Islas de origen volcánico. Albergan numerosas especies relacionadas con el subárido alicantino. Existen además endemismos exclusivos. Destacan las poblaciones de Pardela Cenicienta (*Calonectris diomedea*) y halcón de Eleonor (*Falco eleonora*). La lagartija endémica de Columbretes ha sido recientemente reconocida como especie con la denominación de *Podarcis atrata*. Los rangos de las poblaciones de aves reflejadas en el apartado 3.2 muestran los contingentes mínimos y máximos registrados en el periodo 2003-2008, elaborados a partir de censos oficiales.
