4.2 Quality and importance

Alberga poblaciones nidificantes de 17 especies de aves incluidas en el Anexo I de la Directiva 79/409/CEE. La zona es de especial relevancia para la conservación de aves esteparias. Acoge el 95,8% de los efectivos regionales de Avutarda Común, el 46,5% de Sisón Común y el 20,5% de Ganga Ortega. Desde 2007 nidifican además algunas parejas de Cernícalo Primilla. Presenta también densidades importantes de Alcaraván Común. Cuenta también con una pareja de Águila Real. Los rangos de las poblaciones de aves reflejadas en el apartado 3.2 muestran los contingentes mínimos y máximos registrados en el periodo 2003-2008, elaborados a partir de censos oficiales.
